Divisions/Weights: Madison weight system for all divisions
Pee Wee: 6 and under, as of day of tournament
Bantam: 7 and 8 year olds, as of day of tournament
Midget: 9 and 10 year olds, as of day of tournament

Copy of birth certificate is required if age is challenged

Start Times: Pee Wee: Weigh-Ins 7:30 – Wrestling starts at 8:00 AM
Bantam: Weigh-Ins 9:30 – Wrestling starts at 10:00 AM
Midget: Weigh-Ins 12:30 – Wrestling starts at 1:00 PM

Rules: This is a **NOVICE** tournament designed for wrestlers in their 1st & 2nd year of wrestling only. At the start of each session, all wrestlers will be lined up according to weight and put into 4 man brackets. You will wrestle each person in your bracket, giving each wrestler 3 matches. Experienced coaches and high school wrestlers will serve as referees. PIAA-modified rules. This is meant to be a fun learning experience for all wrestlers. Remember, teaching children honesty in regard to experience is more important than a tournament win!

All bouts will be 1-1-1. Headgear and singlets are encouraged, but not mandatory.

Awards: All wrestlers will receive trophies. Ties will be decided on a positive mark system.

Entry Fee: \$20.00 if registration is postmarked by January 18, 2010. Make checks payable to PWC.
This is NOT a league match. Entry fee **MUST** accompany entry form.
\$25.00 walk-in on the day of the tournament
Pre-registration is **strongly** encouraged! This event filled up quickly with walk-ins last year
Tournament limited to 220 wrestlers.
